Course Description

This course introduces students to foundational knowledge, methods and skills for designing human-centered user experience (UX) around interactive systems. Students will become familiar with user research, concept generation, and design methodologies such as sketching, storyboarding, wireframing, prototyping etc. In addition, students will also learn how to collaborate in a team setting, communicate design rationales, and present compelling narratives about their work. The class will be structured with lectures as well as hands-on design activities, projects and design critiques.

Course Objectives

By the end of this course, students will be able to:

- 1. Learn and apply foundational design knowledge, methods and skills to create effective and compelling UX
- 2. Engage in and respond to constructive design critiques
- Communicate design concepts clearly and compellingly in different phases of the UX design cycle
- 4. Learn how to effectively work as a team

Attendance and Participation

Readings and Quizzes

There will be assigned readings based on the topic(s) for the upcoming week with open-book quizzes to assess your comprehension of the readings at the beginning of class on the Monday of that week. The quizzes will take place online through Canvas and will last 10 minutes. You will not have extra time if you arrive to class late. Quizzes cannot be made up, under no circumstances.

Reflection Journal Entries

You will be required to submit a one-page reflection of what you learned from the lectures, readings, and assignments of the past week each week. The journal entries are an opportunity to keep a log of your learning progression throughout the semester. Journal entries are due Mondays by the start of class and are to be submitted through Canvas (physical submissions will not be accepted).

Individual and Group Projects

There will be three projects, one group-based, two to be completed individually. The group project will be assigned at the beginning of the course where students will work to design, develop, and evaluate a prototype. The individual projects will give students practice on the design thinking process.

- 2. Document was provided of an unforeseeable circumstance(s) (as assessed by the instructor's discretion).

Attendance

You will not be graded directly on attendance. It is expected that you will be present for all course-related activities. Other than an occasional need to be absent from class (for a valid reason), you should plan to be in class.

Towards the latter half of the semester, I may allocate a portion of class time for teams to work on their semester project. If you are absent or are unable to participate in your team meetings, it is your responsibility to communicate to your team regarding your absence and how you can contribute.

Excused Absence: The only absences that will be considered excused are for religious holy days or extenuating circumstances due to an emergency. If you plan to miss class due to observance of a religious holy day, please let me know at least two weeks in advance.
